

Carpool Rules, Information & Agreement

As part of the Rideshare program, participants may apply for a Carpool Permit (CP) allowing access to a reserved space. All participants must complete and sign this Agreement and any other necessary and accompanying forms, and present their Eagle-One card to the Welcome Center & Parking Services office.

1. **Participants must be established College at Brockport parkers for a minimum of one year.**
2. **Each participant must be a member of alternetride rideshare tool.**
3. **Only one single CP will be issued for each carpool, as defined herein. Carpoolers will arrive on campus together in one vehicle.**
4. **A carpool consists of two (2) or more persons riding together in the same vehicle.**
5. **Any vehicle parked in violation of the carpool rules will be subject to a citation and/or towing. No notice will be given prior to towing. Violators will be required to pay the towing and all related charges and carpool privileges may be revoked at the discretion of College administration. At that time, the CP must immediately be returned to Welcome Center & Parking Services.**
6. **A holder of a CP must return the permit at any time that their carpool group cannot comply with this Agreement.**
7. **Both the college-issued permit AND the CP must be clearly and prominently displayed at all times if parking in a car pool space.**
8. **The College does not guarantee a CP space to every CP holder at a given time. If a carpool space is not available, the holder must park in a space designated by assigned college permits.**
9. **CP holders may NOT use a carpool-only parking space when not operating as a valid car pool as defined herein.**
10. **Carpool permits expire at the end of each semester and a new Agreement must be signed for the new CP and the new semester.**

The College at Brockport's carpool program is aimed primarily in support of the campus' *Green Initiative* by reducing the number of single occupancy vehicles. The College at Brockport is not responsible for ensuring the quality or licensing of drivers that participate in the program, or for ensuring that participants' vehicles are roadworthy or sufficiently insured. It is the responsibility of each participant to inquire of proper licensure, insurance and driver skill. Participants are responsible for continually reviewing insurance papers to ensure that adequate coverage is carried for all car pool participants. Participants are strongly encouraged to discuss and/or review the driving records and driving habits of their fellow participants and to inquire in detail about the road-worthiness of the vehicle in question before participating. In addition, please read carefully the following CONSENT, DISCLAIMER and RELEASE before signing below:

1. The College at Brockport does not assume any liability whatsoever, and the undersigned release the College and its' representatives from all actions liabilities, damages, costs, expenses, courses of action, actions, claims, suits or judgments, for loss or damage to any vehicle and/or its contents, or for injury to or death of any person, which arises in the course of, in connection with, or the result of the carpool program, including without limitation, vehicle accidents, driving infractions and any incidents whatsoever involving carpool participants.
2. The undersigned also acknowledges that there are risks he or she knowingly and voluntarily assumes in participating in a Carpool Program, some of which are referred to in this document.
3. The undersigned have consented to the provision by the College at Brockport of his or her name, address and telephone number to the other participants in their car pool group in connection with the operation of the carpool program.

By my signature below, I certify that I am at least eighteen (18) years of age and that I agree to the foregoing rules and procedures of the Carpool Programs as expressed herein. I further agree that I knowingly and voluntarily accept full responsibility for ensuring the roadworthiness and insurance status of carpool vehicles and the safety record of all involved drivers before participating and, in so doing, I knowingly and voluntarily accept and fully assume all such risks, dangers and hazards and the responsibility of personal injury, death, property damage and loss resulting therefrom.

I further agree to waive any and all future claims against the College at Brockport or its designated representatives and assigns and to release the aforementioned from any and all liability for any loss damage, expense or injury, including death, that I may suffer resulting from or arising out of any aspect of my use of the Equipment or from the participation in the Carpool Program. I have read and understood this agreement and I am aware that by signing this agreement, I am waiving certain legal rights which my heirs or I may have against the College at Brockport or its designated representatives.
